

**STANDING
ORDER**

This Court is currently revising its Local Rules of Civil Procedure and Local Rules of Criminal Procedure, effective May 1, 2003 ("Local Rules"). Until the revised Local Rules become effective, in order to be consistent with the time period amendments to the Federal Rules of Civil Procedure and Federal Rules of Criminal Procedure effective December 1, 2009, the following amendments to the Local Rules are hereby adopted by this Court, to take effect on December 1, 2009:
